For far too long, there has been a widespread disengagement of the community, leaving the surrounding neighborhoods without a voice in many of the decisions that directly affect them. I am now part of a loose coalition of younger advocates that are seeking positions on Boards and Commissions trying to once again represent this area of the City as many of the "old guard" begin to step down. Additionally, no one is currently serving on the Board and living in the north Sacramento area.

I have always been interested in water issues. My mother is a retired Army Corps of Engineers, Sacramento District employee. Furthermore, I have a great interest in public works in general. I have toured the Sacramento Regional Wastewater Treatment Plant and Sacramento River Water Treatment Plant several times. Reading past Board packets and listening to the audio recordings of previous Board meetings it appears that homelessness has become a notable burden to the District. While by no means an expert, I have learned a great deal with my time on the North Sacramento Advisory Committee on Homelessness, particularly with issues in North Sacramento and the American River Parkway. It is a phenomenally complex issue and does not present easy solutions. My involvement in many neighborhood issues has brought me into contact with a solid network of community leaders. Lastly, I am a manager of a small business that encourages its employees to volunteer for nonprofit and civic engagements, meaning I am able to commit the hours needed to serve on a Board such as this.

For these reasons I wish to serve on this Board.
